AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the
- schools; amending, revising, consolidating and changing the laws relating thereto," in high schools, further providing
- 6 for courses of study.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 1605 of the act of March 10, 1949
- 10 (P.L.30, No.14), known as the Public School Code of 1949, is
- 11 amended by adding a subsection to read:
- 12 Section 1605. Courses of Study.--* * *
- 13 (d) (1) Beginning with students graduating from a public
- 14 high school at the end of the 2019-2020 school year, and
- 15 continuing in each school year thereafter, a student who
- 16 <u>successfully completes a course in personal financial literacy</u>
- 17 during grades nine through twelve shall be permitted to apply up
- 18 to one credit earned for successful completion of the course to
- 19 <u>satisfy the student's social studies, family and consumer</u>

- 1 science, mathematics or business education credit requirement
- 2 for graduation, provided that the governing body of the
- 3 student's public high school shall have discretion to determine
- 4 the graduation credit requirement to which the credit earned by
- 5 the student shall be applied.
- 6 (2) As used in this subsection, the following words and
- 7 phrases shall have the meanings given to them in this paragraph_
- 8 unless the context clearly indicates otherwise:
- 9 <u>"Personal financial literacy" shall mean the integration of</u>
- 10 various factors relating to personal financial management,
- 11 including understanding financial institutions, using money,
- 12 learning to manage personal assets and liabilities, creating
- 13 budgets and any other factors that may assist an individual in
- 14 this Commonwealth to be financially responsible.
- 15 "Public high school" shall mean a public school, including a
- 16 <u>school within a school district, a charter school, a cyber</u>
- 17 charter school, a regional charter school or an area vocational-
- 18 technical school, that offers twelfth grade.
- 19 Section 2. This act shall take effect in 60 days.
